This Privacy Policy describes Our policies and procedures on the collection, use and disclosure

of Your information when You use the Service and tells You about Your privacy rights and how

the law protects You.

We use Your Personal data to provide and improve the Service. By using the Service, You

agree to the collection and use of information in accordance with this Privacy Policy.

# Interpretation and Definitions Interpretation

The words of which the initial letter is capitalized have meanings defined under the following

conditions. The following definitions shall have the same meaning regardless of whether they

appear in singular or in plural.

### **Definitions**

# For the purposes of this Privacy Policy:

Account means a unique account created for You to access our Service or parts of our Service.

Business, for the purpose of the CCPA (California Consumer Privacy Act), refers to the

Company as the legal entity that collects Consumers' personal information and determines the

purposes and means of the processing of Consumers' personal information, or on behalf of

which such information is collected and that alone, or jointly with others, determines the

purposes and means of the processing of consumers' personal information, that does business

in the State of California.

Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to

Insquad Inc, 256 Chapman Road STE 105-4, Newark, DE 19702.

For the purpose of the GDPR, the Company is the Data Controller.

Consumer, for the purpose of the CCPA (California Consumer Privacy Act), means a natural

person who is a California resident. A resident, as defined in the law, includes (1) every

individual who is in the USA for other than a temporary or transitory purpose, and (2) every

individual who is domiciled in the USA who is outside the USA for a temporary or transitory

purpose.

Cookies are small files that are placed on Your computer, mobile device or any other device by

a website, containing the details of Your browsing history on that website among its many uses.

Country refers to: Delaware, United States.

Data Controller, for the purposes of the GDPR (General Data Protection Regulation), refers to

the Company as the legal person which alone or jointly with others determines the purposes

and means of the processing of Personal Data.

Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.

Do Not Track (DNT) is a concept that has been promoted by US regulatory authorities, in

particular the U.S. Federal Trade Commission (FTC), for the Internet industry to develop and

implement a mechanism for allowing internet users to control the tracking of their online

activities across websites.

Personal Data is any information that relates to an identified or identifiable individual. For the purposes for GDPR, Personal Data means any information relating to You such as a

name, an identification number, location data, online identifier or to one or more factors specific

to the physical, physiological, genetic, mental, economic, cultural or social identity.

For the purposes of the CCPA, Personal Data means any information that identifies, relates to,

describes or is capable of being associated with, or could reasonably be linked, directly or

indirectly, with You.

Sale, for the purpose of the CCPA (California Consumer Privacy Act), means selling, renting,

releasing, disclosing, disseminating, making available, transferring, or otherwise communicating

orally, in writing, or by electronic or other means, a Consumer's Personal information to another

business or a third party for monetary or other valuable consideration.

Service refers to the Website.

Service Provider means any natural or legal person who processes the data on behalf of the

Company. It refers to third-party companies or individuals employed by the Company to

facilitate the Service, to provide the Service on behalf of the Company, to perform services

related to the Service or to assist the Company in analyzing how the Service is used. For the

purpose of the GDPR, Service Providers are considered Data Processors.

Third-party Social Media Service refers to any website or any social network website through

which a User can log in or create an account to use the Service.

Usage Data refers to data collected automatically, either generated by the use of the Service or

from the Service infrastructure itself (for example, the duration of a page visit).

Website refers to Insquad inc., accessible from https://getsally.ai

You means the individual accessing or using the Service, or the company, or other legal entity

on behalf of which such individual is accessing or using the Service, as applicable.

Under GDPR (General Data Protection Regulation), You can be referred to as the Data Subject

With Sub-processors: To deliver the Services, The Company engages third-party service providers as sub-processors. By using the Services, you give use permission to share your information with said third-party service providers so that we can provide you with the Services.

For Business transfers: We may share or transfer Your personal information in connection

with, or during negotiations of, any merger, sale of Company assets, financing, or acquisition of all or a portion of our business to another company.

With Affiliates: We may share Your information with Our affiliates, in which case we will

require those affiliates to honor this Privacy Policy. Affiliates include Our parent company

and any other subsidiaries, joint venture partners or other companies that We control or that

are under common control with Us.

With Business partners: We may share Your information with Our business partners to

offer You certain products, services or promotions.

With other users: when You share personal information or otherwise interact in the public

areas with other users, such information may be viewed by all users and may be publicly distributed outside. If You interact with other users or register through a Third-Party

Social Media Service, Your contacts on the Third-Party Social Media Service may see Your

name, profile, pictures and description of Your activity. Similarly, other users will be able to view

descriptions of Your activity, communicate with You and view Your profile.

#### **Retention of Your Personal Data**

The Company will retain Your Personal Data only for as long as is necessary for the purposes

set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary

to comply with our legal obligations (for example, if we are required to retain your data to comply

with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is

generally retained for a shorter period of time, except when this data is used to strengthen the

security or to improve the functionality of Our Service, or We are legally obligated to retain this

data for longer time periods.

### **Transfer of Your Personal Data**

Your information, including Personal Data, is processed at the Company's operating offices and

in any other places where the parties involved in the processing are located. It means that this

information may be transferred to — and maintained on — computers located outside of Your

state, province, country or other governmental jurisdiction where the data protection laws may

differ than those from Your jurisdiction.

Your consent to this Privacy Policy followed by Your submission of such information represents

Your agreement to that transfer.

The Company will take all steps reasonably necessary to ensure that Your data is treated

securely and in accordance with this Privacy Policy and no transfer of Your Personal Data will

take place to an organization or a country unless there are adequate controls in place including

the security of Your data and other personal information.

# Disclosure of Your Personal Data Business Transactions

If the Company is involved in a merger, acquisition or asset sale, Your Personal Data may be

transferred. We will provide notice before Your Personal Data is transferred and becomes

subject to a different Privacy Policy.

#### Law enforcement

Under certain circumstances, the Company may be required to disclose Your Personal Data if

required to do so by law or in response to valid requests by public authorities (e.g.

a court or a government agency).

## Other legal requirements

The Company may disclose Your Personal Data in the good faith belief that such action is

necessary to:

Comply with a legal obligation

Protect and defend the rights or property of the Company

Prevent or investigate possible wrongdoing in connection with the Service

Protect against legal liability

# **Detailed Information on the Processing of Your Personal Data**

# **Analytics**

We may use third-party Service providers to monitor and analyze the use of our Service.

## **Google Analytics**

Google Analytics is a web analytics service offered by Google that tracks and reports website

traffic. Google uses the data collected to track and monitor the use of our Service.

This data is

shared with other Google services. Google may use the collected data to contextualize and

personalize the ads of its own advertising network.

You can opt-out of having made your activity on the Service available to Google Analytics by

In any case, the Company will gladly help to clarify the specific legal basis that applies to the

processing, and in particular whether the provision of Personal Data is a statutory or contractual

requirement, or a requirement necessary to enter into a contract.

## **Your Rights under the GDPR**

You have chosen, Your Personal Data in a structured, commonly used, machinereadable format. Please note that this right only applies to automated information which

You initially provided consent for Us to use or where We used the information to perform

a contract with You.

Withdraw Your consent. You have the right to withdraw Your consent on using your

Personal Data. If You withdraw Your consent, We may not be able to provide You with

access to certain specific functionalities of the Service.

# **Exercising of Your GDPR Data Protection Rights**

You may exercise Your rights of access, rectification, cancellation and opposition by contacting

Us. Please note that we may ask You to verify Your identity before responding to such requests.

If You make a request, We will try our best to respond to You as soon as possible. You have the right to complain to a Data Protection Authority about Our collection and use of

# **Your Rights under the CCPA**

Under this Privacy Policy, and by law if You are a resident of California, You have the following

The right to notice. You must be properly notified which categories of Personal Data

are being collected and the purposes for which the Personal Data is being used. The right to access / the right to request. The CCPA permits You to request and
